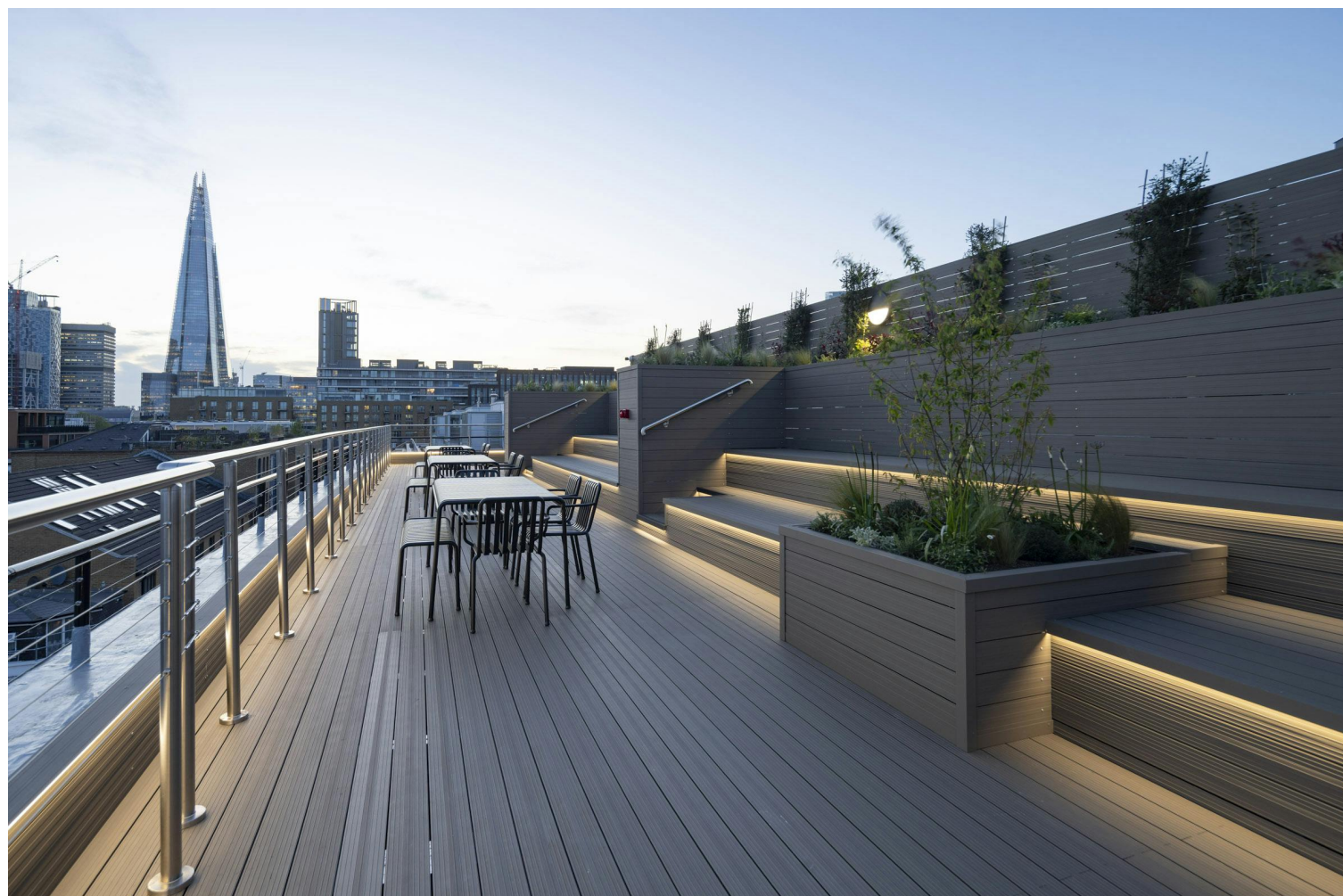

The 1st floor is part-fitted with a kitchen and x3 meeting rooms with the option to split the floor to provide two separate units.

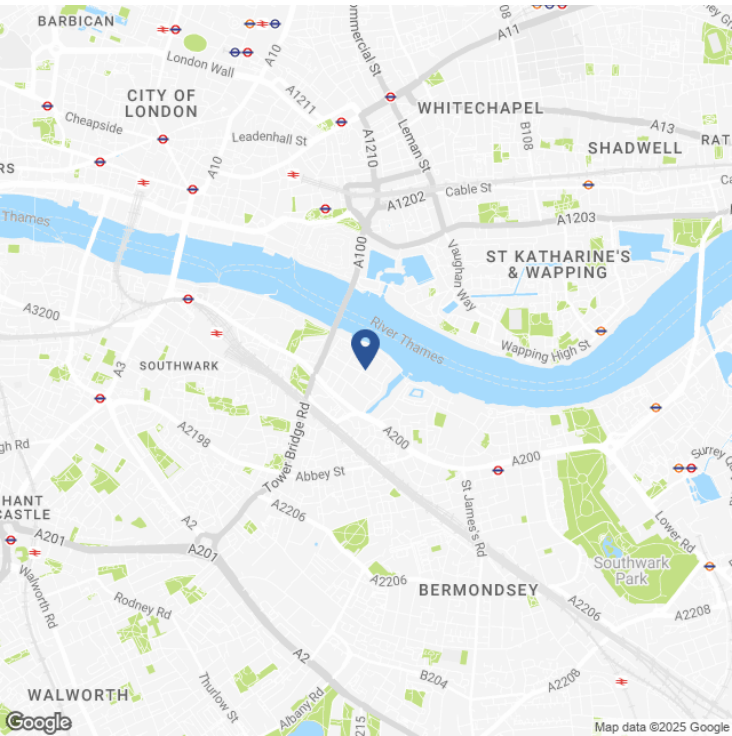
## LOCATION
